

## Meeting Notes 26/10/10

The planned meeting for October 21<sup>st</sup> was cancelled due to attendee sickness and subsequently rearranged for Tuesday 26<sup>th</sup> October.

1. The minutes of the September 23<sup>rd</sup> had been circulated prior to the meeting. A comment from Karen Ashworth regarding an action for a formal letter of invite to Playing committee had been omitted from the minutes. It has been noted that action is now no longer needed.
2. Update on Play Park Project  
A meeting with interested parties was well attended on 13<sup>th</sup> October 2010 and a copy of minutes supplied . It has been proposed to the Playing fields committee that the most beneficial way forward would be a merger of the two groups. A decision on this is expected on 10<sup>th</sup> November which is the next meeting of the play park project. It was also noted that work to make the existing site safe begins on 30<sup>th</sup> October with the demolition of the old pavilion. Action for JW to provide SD with original material from the visioning event in time for next meeting of the play park project. (Completed)
3. Follow on events with young people  
December 3<sup>rd</sup> has been suggested for a Christmas Kids Disco to be followed by Carol Singing and Christmas Light switch on. With a small charge being made for the disco which will be the start of the fundraising activities. Other fundraising event ideas such as bonfire and winter ball were rejected for this year but may be an option for next year when more time to plan them would be available.
4. Finances  
No volunteers have been forthcoming for treasurer however we will need to open a bank account . Action for JW to establish from her bank Lloyds TSB what options are available and bring back any material back to group at next meeting . SD also volunteered to pick up information from Lincoln.

## 5. Questionnaire

Reviewed Version 2 with the following observations to be passed on to Andrew Young.

Section 5.7 Remove line (d) and replace with "Poor - needs improvement"

Section 5.9 item (a) doesn't make sense and was not clear as to what being asked is it that the volume of seating and tables need to be increased or is it that comfortable seating is needed. It was thought to be the latter therefore suggest rewording to "Comfy Seating Area"

Section 5.9 add item (f) "Improved Bathroom facilities"

Section 6.1 wording changes as follows

(a) Regularly - more than 6 times a year.

(b) Occasionally - Up to 6 times a year.

Section 6.6 Wording change to read

"Would you be interested in helping CLP achieve any of the above."

Section 7 rename section to read "Highways"

Section 7.2 additional word "excessive" to be added.

Section 7.3 item (d) add "Rumble Strips"

Create Item (f) "One Way System"

There are two section 7.11 re – number second to read 7.12 and add the following statement "If not state why not"

Original 7.12 to be deleted.

Section 7.14 change to "Do you have any other comments relating to Section 7"

Section 8.1 Change "Bonfires" to read "Burning Rubbish"

Section 8.2 item (d) remove "and do what is natural for them"

Section 8.3 item (h) to read "More dog waste bin signs"

Section 8.3 item (i) is for other comments.

Section 11.1 spotted a typing error "of" should read "or"

Section 11.2 remove section as it is too negative

It was also suggested that we have a page for the young people to fill in which would be printed on a different coloured paper .

At the end of the questionnaire there needs to be Thank you statement to include when we intend to call back to collect the questionnaire.
