Cllr Mary Green reported:

"Local Democracy Week took placed in October. Two schools hosted the events, Carres Grammar in Sleaford and Sir William Robertson in Welbourn. Both days hosted students from other schools in the district and all attendees - including district Councillors - got involved in 'Mock Elections'. "A great success" was the overall feedback to the days with the students campaigning on various topics but interestingly they were all involving climate change and the environment. Thanks go to Democratic Services for all the hard work under gone arranging the events and on the days, giving advice and quidance on the history and democracy of our electoral system.

The Norton Disney Rendering Plant application is listed for discussion and comment by NK Full Planning Committee as a statutory Consultee on 8th January 2020.

General Election 12th December 2019

It is important we remind residents who are not currently registered, of the need of registering to vote in time for the election.

Operation Raptor launched last week gives people in Lincolnshire the opportunity to surrender their unlicensed/unwanted weapons so members of the public can make sure they do not potentially fall in to the hands of criminals. Although the operation is focussed on the west of the county, anyone in the county can take their weapons to police stations at Lincoln, Grantham, Skegness and Boston. During the period those giving up firearms will not face prosecution at the point of surrender and they can remain anonymous. However, this is a surrender and not an amnesty, police may investigate offences in relation to firearms once the operation has concluded.

Motorists are warned to expect icy roads - it's that time of year again, extra care is needed following the recent heavy rains. Lincolnshire gritters are now on call 24/7 until April 2020.
